Fund Description

The iShares MSCI USA ESG Select Social Index Fund seeks to provide investment results that correspond generally to the price and yield performance, before fees and expenses, of the MSCI USA ESG Select Index ("the Index").

Index Description

The MSCI USA ESG Select Index is designed to measure the equity performance of large capitalization companies that have positive environmental, social, and governance ("ESG") characteristics relative to their industry and sector peers and in relation to the broader market, while exhibiting risk and return characteristics similar to the MSCI USA Index. The Index consists of approximately 250 companies from the universe of companies included in the MSCI USA Index. MSCI evaluates each eligible company's ESG performance using standardized criteria and assigns an "overall rating" to each company. The selection process is designed so that companies with relatively high overall ratings have a higher representation in the Index than in the MSCI USA Index. Companies with relatively low overall ratings have a lower representation in the Index than in the MSCI USA Index. Companies that MSCI determines are involved in the tobacco industry are excluded from the Index.

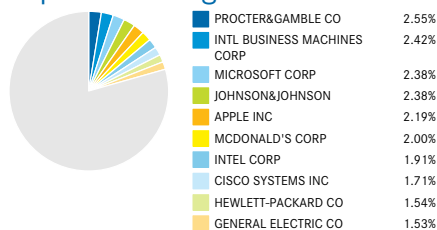

iShares MSCI USA ESG Select Social Index Fund



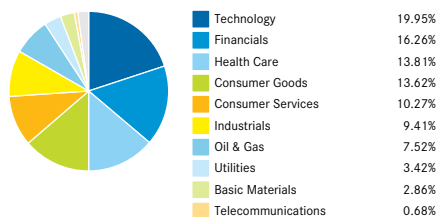
