## Index Description

The S&P Developed ex US Property Index defines and measures the investable universe of publicly traded real estate companies domiciles in developed countries outside of the United States. The companies in the index are engaged in real estate related activities, such as property ownership, management, development, rental and investment.

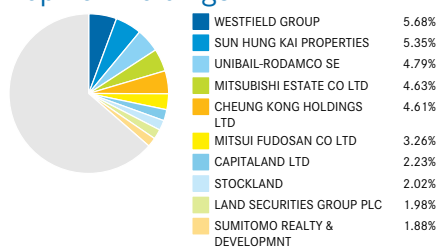

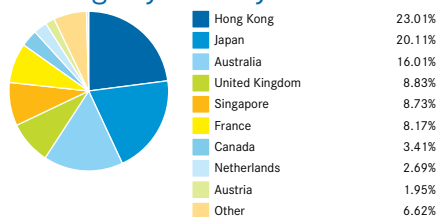
